Dear Members of the Town of Oregon Plan Commission:

As most of you are aware, I am interested in developing a conservation subdivision on the 35.4 acres of my property, located at 1000 Wesley Road, Oregon, WI 53575-2686. Please use this letter as an official request to do so.

A preliminary sketch of the proposed layout is enclosed, entitled "Krebsbach - Conservation Subdivision - Concept Map 2." It would involve nine additional lots (in addition to where my current home is located) that are between 1.00 and 1.33 acres. The total developed land would involve 11.35 acres and the rest of the 24.05 acres would remain a part of the existing tall grass prairie for perpetuity.

It is my understanding that the Town of Oregon is requesting the following three studies be done prior to granting approval:

- 1. Nitrate/Groundwater study (which would include a Certified Soil Test(s))
- 2. Storm water management study
- 3. Traffic analysis study


I am working with a planner to initiate the first two and the Town of Oregon will initiate the third.

During this time, I had made the statement that it was obvious that Susan had not informed her neighbors about the conservation subdivision like she had previously said she had done.
