ROAD & SAFETY COMMITTEE

October 2008, Town Board Chairman Weber created a Town Road & Traffic Safety Committee. Members are Chairman Wayne Ace, Chris Johnson, Dave Hagemann, Robert Kujawa and Gary Wackett. Public safety is the goal of this committee. In order to accomplish this goal, the committee identified issues to be addressed and developed a system for the identification and completion of safety and traffic concerns. The issues identified were:

1. Signage (quality, installation of new signs & additional signs required)
2. Road conditions (potholes & major roadwork to be budgeted)
3. Tree trimming and right of way clearance (branches & brush for safe mowing and snowplowing)
4. Intersections & driveways (safety issues with stop signs & obstructions)
5. Shoulders & culverts (washed out, filled in, shoulder levels & frequency of mowing)
6. Parks (need for trash containers & other safety issues)

This fall the committee members inspected the town's signs and the town road crew will be replacing and installing new signs as recommended. Other road and safety issues will be addressed as the weather improves and as the committee is made aware of concerns. BUILDING PERMITS – DO YOU NEED A PERMIT?

If you are: altering an existing building, constructing a new building, doing major repairs, adding a solar collector, adding a bay or bow window, cleaning out drainage ditches or ponds, doing any brush or tree cutting, filling or grading in a floodzone, wetland or shoreland area, you probably do need a zoning permit. For information call: Dane County Zoning 266-4266.

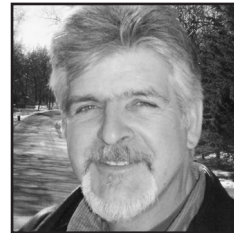

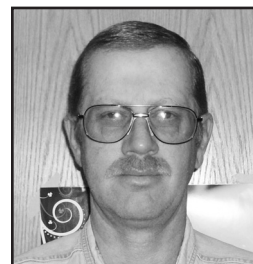

CONSTABLE'S REPORT

The following is the 2008 Annual Report of the Town Constable. 6770 patrol miles and 381 hours were logged. Patrol miles and hours do not include miles and hours for committee and board meetings. Hours also do not include time for reports, logs and

general question calls for weed complaints.

87 reports were prepared. 238 park checks were made. 5 vacation checks were made. 3 weed complaints were checked. 27 citations were issued, for a bond amount of \$4431.50 before court. 16 written warnings were issued.

The following is a break down of reports written: 9 assist Oregon EMS, 1 assistant Brooklyn EMS, 1 assist Brooklyn Police, 1 illegal dumping, 15 animal, 2 check area, 3 check persons, 5 damage to property, 1 noise, 3 fireworks, 2 unsecured property, 1 disturbance, 1 storm damage dispatched to 21 incidents, and 27 citation reports.

EMERGENCY MANAGEMENT

Emergency Management is new to the township newsletter. You may wonder what Emergency Management is? Emergency management is the pre-planning and response to natural and man-made disasters. The Emergency Management Committee currently consists of four members from the township. Since the last 1990's, the

Federal, State and County Governments have required all municipal governments to have a disaster plan on file. The plan is only one of many steps needed to get Federal assistance in case of a declared disaster. Other requirements are to have Town officials certified with NIMS (National Incident Management System) training. The newest requirement that is in the initial stages is a mitigation plan.

2009 will keep the Committee busy with required updates. In addition, the township will be working with area emergency responders to set-up planning response in case of a disaster.

Hopefully, we will never have to use this plan. However, if a disaster does happen, the township will be ready to respond to the residents needs.

PARK COMMITTEE

The Eagle Scout sign located outside the Town Hall is in recognition of the scouts earning their Eagle Scout status and the contributions made to the town. The sign was made by Tom Wollin who also made the sign at the Town Park. In celebration of Arbor Day in Wisconsin April 24, local residents, neighbors and youth groups will

plant trees in two Town of Oregon parks. Spearheading the project is Kathy E. Esch. In 2006 & 2007 over 50 trees were planted with the help of neighbors in Kennedy Park. In 2008, 50 trees were planted at Town Park and another 5 at Kennedy Park. Project volunteers are needed for digging holes, planting trees, hauling water, watering trees for up to

SNOWPLOWING – PREVENT SNOW DAMAGE TO YOUR MAILBOX

In Wisconsin snow removal operations frequently conflict with mailboxes. Mailbox installations that have been successful in reducing the number of mailboxes damaged or demolished by snow removal feature a 24 to 36 inch "arm" at a 46 inch height. This allows the snow plow to remove snow closer to the mailbox and maintain a greater distance from the post. Mailbox installations do require regular maintenance and must withstand the weight of wet snow being pushed on them by a snow plow. After several years of freezing and thawing, mailboxes may need to be re-installed. The Town does not pay for or replace mailboxes that collapse due to snow removal efforts.

COMPREHENSIVE LAND USE PLAN AND FARMLAND PRESERVATION PLAN

The Town is still working towards getting final approval of the completed Comprehensive Plan. The Town has received approval for the Farmland Preservation Plan. The state has given the town a deadline of December 31, 2009 to complete a blanket re-zone of 234 parcels in the Town of Oregon. Affected landowners will be notified shortly.

CENSUS 2010

The United States Constitution requires for purposes of apportionment and redistricting a census of the United States be taken every ten years. In the year 2010, The U.S. Census Bureau will conduct a census

across our Nation to enumerate the U.S. population. The decennial census provides the information each community needs to obtain its fair share of funding for health assistance, services for older adults, employment services, schools,

and more. 2010 Census questionnaires will not be delivered to households until mid-March of 2010, but the census awareness campaign has started TODAY.

- OPEN BOOK & BOARD OF REVIEW** Dates have not been set. If you have questions, please contact the assessor, Andy Blomstrom at 835-5321.
- BURN PERMIT:** The Town does not require residents to obtain a burning permit, HOWEVER you must contact your fire department before you burn.
- NOXIOUS/INVASIVE WEEDS:** State Law requires every property owner to cut or destroy Canadian Thistle, Leafy Spurge and Field Bindweed (commonly known as Creeping Jenny) to prevent them from going to seed or spreading to adjoining properties. Any questions, please contact our constable Gary Wackett at 445-5673.
- FIREWORKS PERMIT:** Wisconsin State Statute 167.40 requires the Town of Oregon to issue Fireworks Permit for any person possessing or using fireworks. Permits can be obtained at the Clerk's office and cost \$2.00.
- DOG LICENSE:** All dog(s) five months of age or older must be licensed. Fees: Male/Female \$17.50 Spayed/Neutered \$11.50 Kennel License: \$45.75. Any questions, please contact Rhonda La Flash at 516-1635.

TORC NEWS

The Town of Oregon has changed to Pellitteri Waste Systems for waste disposal and recycling hauler at the TORC. At the TORC you can recycle: paper & flattened cardboard products (magazines, envelopes, news-paper, Kleenex boxes, cereal boxes), plastic (#1 through #7), glass bottles/containers, aluminum/tin and steel. The TORC will continue to keep aluminum cans and metal separate from the all-in-one recycling. Pellitteri will also be providing residents with a household bulky item pickup option. Please call Pellitteri at 257-4285 to discuss pickup days and pricing. The Town has seen a significant saving since switching to Pellitteri as of January 1st, 2009.

ATC POWER LINES

The PSC is now in the final stages of deciding the location of the Rockdale - West Middleton Transmission Line. ATC has submitted a proposal for a 345-kilovolt transmission line to reinforce Dane County's transmission network. One of

the lines would be through the Town of Oregon. More detailed information, including route maps, fact sheets and other project-specific information can be found on the projects website at www.atc-projects.com. PSC Hearings will be held on March 24-25, 2009,

1:00 & 6:00 p.m. at the PSC Office (610 N. Whitney Way, Madison). The Town has formally notified the PSC that it is opposed to any lines in the Town of Oregon.

ALL-HAZARD WARNING RADIOS (WEATHER RADIOS) WILL BE AVAILABLE AT THE TOWN HALL

The Town of Oregon will partner with Dane County Emergency Management to distribute all-hazards warning radios (a/k/a weather radio) to the public.

About the radio: The radio is the Reecom Model R-1630 All-Hazards/Weather Alert Radio. Features include:

- Programmable – Specific Area Message Encoding (SAME) allows the user to program the radio to alert for only the desired location and warning types
- Battery backup – the radio will still work if power is lost
- Visual display of warning information
- Relay to activate external devices like a bed shaker or strobe light for people who are deaf or hard of hearing.
- Includes a jack for an external antenna if needed to improve reception
- Alerts by voice announcement or tone.

Radio retails for \$59.99. Our purchase price: \$25.00 (approximate price) plus tax. We will be limited to sell no more than two radios per household. We expect to have radios available at the Town Hall by April 1, 2009.
