**RESCINDING THE BOARD OF ABSENTEE CANVASSERS AND THE CENTRALIZED
CANVASSING OF ABSENTEE BALLOTS**

WHEREAS, the Town Board previously adopted Ordinance 90 pursuant to section 7.52 of the Wisconsin Statutes, creating a Board of Absentee Canvassers and authorizing the central counting of absentee ballots on election day; and

WHEREAS, the Town Board determines it is in the public interest to rescind Ordinance #90.

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Oregon, Dane County, Wisconsin, does ordain as follows.

SECTION 1. Ordinance 90 is hereby repealed and rescinded pursuant to section 7.52(9), Wis. Stats.

SECTION 2. Section 2.60 of the Code of Ordinances pertaining to the Municipal Board of Absentee Canvassers is hereby repealed.

SECTION 3. After the effective date of the Ordinance, the absentee ballots at all election held in the Town shall be canvassed as provided in section 6.88, Wis. Stats.


SECTION 4. All other provisions of the Code of Ordinances not specifically amended herein shall remain unmodified and in full force and effect.

SECTION 5. This ordinance shall take effect upon passage and publication as provided by law.






